Despite the Pretoria Cessation of hostilities agreement, the Ethiopian Government continued the weaponization of restricted access to humanitarian aids, food and medicine. The Ethiopian Government also failed to declare the withdrawal of Eritrean forces and other rebel groups that invaded Tigray and continued to loot, destroy properties and infrastructures as well as committing atrocious crimes such as rape, extrajudicial killing and massacring in territories that are still occupied (#Southern Tigray, #Irob, #Kunama, and Western Tigray)

Tigray has been the target of war crimes and human rights violations. Reports suggest that the population has been subject to attacks, displacement and starvation. Systematic abuses have been documented by the UN, yet there has been no international investigation into the situation despite numerous calls from the international community. Government of Ethiopia has been engaged in different types of deceptive propaganda in attempt to confuse and confuse the Int'l community as it continues committing crimes and at the same time hide its crimes and violations of Human rights in Tigray. Government of Ethiopia has been resisting and discrediting international organizations that inquire any information in regards to Human rights violations in Tigray. For example: -

The Ethiopian government has been consistent in opposing the African commission on human and people s right (#ACOHPR). It has been discrediting the establishment of the Commission of Inquiry since its establishment on the 15th of June, 2021. The Ethiopian Ministry of Foreign Affairs said in June of 2021 that the ACHPR's unilateral decision to establish an inquiry commission was "completely outside the scope of the invitation by the government and lacks legal basis"
